### **DIRECTIONS TO THE CLARK COUNTY FAMILY COURT AND TO THE REGIONAL JUSTICE CENTER**

Most departments of the family court are located at the Family Court. Some Family Judges have courtrooms in the Regional Justice Center. Child support hearings for cases that begin with the letter R are heard at the child support office. Please verify with the legal assistant assigned to your case as to which court you have to attend. Below is a set of directions to the courts.

#### **DIRECTIONS TO FAMILY COURT LOCATED AT 601 N. PECOS RD. LAS VEGAS, NV 89101**

FROM I-95, EXIT AT EASTERN AVE.  
HEAD NORTH TO BONANZA  
TURN RIGHT ON BONANZA  
TURN LEFT ONTO PECOS  
TURN LEFT INTO THE PARKING LOT  
THE COURTHOUSE IS THE BUILDING CLOSEST TO THE CORNER  
THERE IS FREE PARKING THROUGHOUT THE PARKING LOT

TAKE I 15 FWY SOUTH  
TAKE EXIT 42 FOR U.S. 95 FWY SOUTH  
MERGE ONTO 95 FWY SOUTH  
TAKE EXIT 75B N. CASINO CENTER BLVD. TOWARD DOWNTOWN LV  
TURN LEFT ONTO LEWIS AVE.  
COURT WILL BE ON THE RIGHT

YOU WILL NEED TO FIND PARKING AT A METER ON THE STREET, A LOT OR A GARAGE. THE STREET METERS TAKE CREDIT CARDS. THERE IS A PUBLIC PARKING LOT TO THE SOUTH OF THE COURTHOUSE THAT TAKES QUARTERS AND COSTS MUCH LESS THAN THE CREDIT CARD PARKING METERS. THERE IS A CHANGE MACHINE ON THE NORTH EAST SIDE OF THE LOT.
